



Tá an polasaí OSPS bunaithe ar ráiteas mhisean Ghaelcholáiste Phort Láirge agus an curaclam mar atá leagtha síos ag an Roinn Oideachais & Scileanna. Is scoil Chaitliceach Lán-Ghaeilge atá i nGaelcholáiste Phort Láirge ach a chuireann fálte roimh fhéiniúlachtaí éagsúla eile chomh maith. Táimid faoi phátrúnacht an Fhorais Phátrúnachta na Scoileanna Lán-Ghaeilge. Tugtar áit do dhaltaí ar an dtuiscint go bhfuil siad sásta glacadh go hiomlán le héiteas Chaitliceach, Lán-Ghaeilge na scoile. Baineann an polasaí seo le polasaithe eile an Choláiste m.sh An Polasaí Caomhnú Leanaí, An Polasaí Frith- Bhulaíochta agus Cód lompair an Choláiste.

- Is as aidhm iomlánaíoch seo an oideachais agus as an mbunfhís seo don duine a thagann an tiomantas i leith an oideachais i réimse na forbartha pearsanta agus sóisialta. Tá fíos iomlánaíoch i leith na sláinte taobh thiar dá leithéid de thiomantas freisin – fíos a chuimsíonn gnéithe fisiceacha, intinne, mothúchánacha, spioradálta, sóisialta agus timpeallachta, agus an t-idirghníomhú casta idir na gnéithe sin uile a chuireann leis an dea-bhraistint phearsanta agus le caidrimh idirphearsanta dhearfacha.
- Toisc na físe iomlánaíche sin den duine, atá i gcroílár ár dtuisceana ar an oideachas agus ar an tsláinte, aithnítear go mbaineann an tábhacht chéanna leis an oideachas sóisialta, pearsanta agus sláinte a sholáthraítear don aos óg agus a bhaineann le réimse ar bith eile den churaclam ionas iad a ullmhú chun páirt a ghlacadh sa tsochaí shibhialta agus sa saol oibre.
- Tá an t-ábhar ag súil le feabhas a chur ar scileanna sóisialta na ndaltaí freisin le féin mhuinín, féin mheas agus spiorad a chruthú iontu ionas gur féidir leo feidhmiú mar dhaoine neamhspleácha muiníneacha sa todhchaí amach rompu. Beidh béim ar chaidrimh shláintiúla a chothú le daoine eile freisin ionas go mbeidh said in ann líonra tacaíochta a chruthú i measc a gcairde féin i ndiaidh scoile.

This SPHE policy is based on the Gaelcholáiste's mission statement and on the curriculum as set out by the Department of Education and Skills. Gaelcholáiste Phort Láirge is an Irish Medium Catholic school that welcomes people with various other identities as well. We are under the patronage of an Foras Patrúnachta for Irish medium schools. Places are provided for students on the understanding that they are happy to fully accept the school's all Irish Catholic ethos. . This policy is linked to other policies of The College for example The Child Protection Policy, The Anti-Bullying Policy.

- *From this holistic aim of education and from this fundamental vision for the individual comes a commitment to education in the field of personal and social development. A holistic vision of a person's health is behind this commitment as well – a vision that encompasses physical, mental, emotional, spiritual, social and environmental aspects and the complex interaction of these aspects of a person's health ,that adds to personal well-being and positive social interaction.*
- *As a result of this holistic vision of a person that is at the heart of our understanding of education and health, it is recognised that the same importance is associated with providing social, health and personal education to young people as is associated with any other aspect of the curriculum in order to prepare them socially for society and for the world of work.*
- *The subject hopes to improve students' social skills as well as their self-confidence, self-respect and to create a spirit within them so that they can function as independent and confident people in the society that lies before them. There will be an emphasis on maintaining healthy relationships with other people with the view that they will develop a support network amongst their friends after school.*

- *The students are encouraged in OSSP class to consider and assess different viewpoints in relation to issues of morality. We firmly believe that the whole life of the school is enriched through respecting the needs of minority groups and individuals.*
 - *The SPHE classes operate on the basic principles of The School's Code of Behaviour, which states "Everyone in the school will respect all member of the school community with an emphasis on courtesy and respect. Discrimination, serious misconduct or disrespect will not be accepted on the grounds of: Race, Religion, Disability, Sexual Orientation or Transgender Orientation, Social Status, Family Status, Age or Association with The Travelling Community . There will be a tolerance towards differences and personalities. We expect that students show respect for the dignity of other students; show respect towards each other and to be courteous and mannerly towards each other always.... They also have the right to expect respect for their own dignity".*
 - *In order to achieve the subject's vision, a positive, productive and challenging atmosphere will be created in class that is open to every culture and that caters to the learning needs of all.*
 - *This is done through the medium of Irish and it is an additional aim in this school that the Irish language is promoted in every subject as a natural life-long language of communication.*

Planning:

*The Social, Personal and Health Education (**SPHE**) curriculum is provided to students of Gaelcholáiste Phort Láirge from first to sixth year. First, Second and Third Year students have one forty minute **SPHE** class per week. Transition Year Students do a double class, one hour and twenty minutes of Personal Development per week. Fifth and Sixth Year students have one single class, forty minutes of Personal and Spiritual Development per week.*

These are the aims of the SPHE curriculum in Gaelcholáiste Phort Láirge:

- *To instil confidence, well-being and a feeling of belonging in students.*
- *To demonstrate to students ways of being responsible for their own actions.*
- *To help students to be more self-aware and sympathetic towards each other by helping them to manage their own emotions, to recognise their individual strengths and to deal with all kinds of change in their lives.*

B. Fealsúnacht Ghaelcholáiste Phort Láirge

Déanaimid iarracht forbairt a dhéanamh ar phearsantacht iomlán an dalta, a thuiscint ar an gceart, ar an léann, ar an tsaoirse, ar an bhféinsmacht agus comhbhá le daoine eile.

Relationship and Sexuality Education (RSE):

This part of the policy , RSE, was enacted after consultation between The Board of Management, staff, parent representatives and the Principal .

A. Scope

In drafting this policy legislation, various guidelines, school policies and the following circulars were taken into account, as well as the school ethos:

- *The school's Antibullying Policy*

The Policy encompasses every aspect of teaching and learning in relation to Relationships and Sexuality Education (RSE). Dialogue, regarding this aspect of the curriculum, occurs also in other classes, as well as SPHE and RSE and it is important that all teachers, as well as management, parents, pupils and guest speakers / facilitators are familiar with the policy.

B. The Philosophy of Gaelcholáiste Phort Láirge

In school, the pupils will come to know the valuable aspects of life, through good example, through guidance and through friendship with the school staff.

We try to develop the full personality of the pupil, his/her understanding of right, of learning, of freedom, of self-discipline and empathy with other people. We understand how important it is that parents participate with us in promoting these values in school, at home and in life.

The Policy is in accordance with these Aims and with the Catholic ethos of the school, and it enables pupils to develop character and values in relation to their own sexuality in a moral, spiritual and social framework. It also gives them the opportunity to learn about relationships and sexuality in ways which help them think and act in a responsible manner.

C. Definition of Relationships and Sexuality Education

Relationships and Sexuality Education is a central part of the social and personal development of the pupil. Parents, as the primary educators of their children, provide information on this at home and the school supports this education by providing classes to each year group which give pupils the opportunity to develop, in a structured way, an understanding of, and a positive attitude to, human relationships, sexuality and identity.

D. The Aims of Relationships and Sexuality Education Programme

Relationships and sexuality education which is located in the overall framework of Social, Personal and Health Education, has as its specific aims:

- *To help pupils understand and develop friendships and relationships.*
- *To promote an understanding of sexuality.*
- *To promote a positive attitude to one's own sexuality and in one's relationship with others.*
- *To promote knowledge of and respect for reproduction.*
- *To enable pupils to develop attitudes and values toward their sexuality in a moral, spiritual and social framework in keeping with the policy of the school.*
- *To provide opportunities for pupils to learn about relationships and sexuality in ways that help them think and act in a moral, caring and responsible way.*
- *It is acknowledged that in a course of limited duration these aims are aspirational.*

E. The Management and Organisation of Relationships and Sexuality Education in our School

1. Arrangements regarding the teaching of the programme and the deployment of staff will be made by the Principal.

2. Parents' Role / Withdrawal

Parents are the primary educators of their children and the school recognises their important role in

3. Comhairle a chur ar fáil

Is é feidhm na scoile oideachas ginearálta a chur ar fáil faoi chúrsaí gnéasachta agus ní comhairle, eolas ná comhairleoireacht aonair a thabhairt ar ghnéithe a bhaineann le hiompar gnéis agus frithghiniúint - ach déanfar foinsí maidir le heolas agus comhairle ghairmiúil a sholáthar nuair is cuí. Is féidir le múinteoirí eolas agus oideachas a chur ar fáil do dhaltaí maidir le cá háit agus cé uaidh ar féidir leo comhairle agus cóireáil ghnéis a fháil, m.sh. a ndochtúir nó gníomhaireacht oriúnach eile. Níor chóir go mbeadh comhairle a thugtar treorach agus ba chóir go mbeadh an chomhairle oriúnach d'aois an dalta.

4. Saincheisteanna

B'fhéidir nach mbeadh sé oriúnach déileáil le ceisteanna neamhbhalbha áirithe sa rang. Tá cead ag múinteoirí a rá nach cuí déileáil leis an gceist sin ag an am seo. Má thagann imní ar mhúinteoir faoi aon ní a ardaíodh ba cheart dó/di comhairle a lorg ón gComhordaitheoir OSPS nó ón bPríomhoide. Agus é/í ag socrú ar cheisteanna a fhreagairt nó gan a fhreagairt ba chóir dó/di aois agus inmhe na scoláirí, an t-ábhar atá sa chlár OCG, sainmheon na scoile, agus an polasaí OCG a chur san áireamh.

5. Rúndacht

Is é polasaí na scoile é go gcaithfidh múinteoir dul i gcomhairle láithreach leis an Duine Idirchaidreamh Ainmnithe (an Príomhoide) má mheastar go bhfuil dalta i mbaol míúsáide de chineál ar bith nó ag sárú an dlí. Cinnfidh an Príomhoide ar na tuismitheoirí agus/nó na húdarás chuí a chur ar an eolas nó gan iad a chur ar an eolas de réir na Nósanna Imeachta maidir le Caomhnú

education concerning relationships and sexuality. This policy was drafted in consultation with parents' representatives and the views of parents will be taken into account when reviewing the policy. This policy will be made available to the school community on the school website.

Normally this part of the SPHE programme is taught to the students in the last term of the school year. It's a 6 week programme. A letter and permission form will be sent to parents when the RSE module of the SPHE programme is about to commence setting out the topics to be covered. They will also be informed that it is their right to withdraw their child but that this must be communicated in writing. Any worry or anxiety expressed will be dealt with sympathetically. [See Appendix 5]. Appropriate arrangements will be put in place for pupils who are withdrawn. At the same time, care will be taken not to undermine the RSE programme and the entitlement of the other pupils.

The HSE provides a module for 5/6 weeks for Transition Years on RSE. The parents receive a letter in advance informing them of this programme, which has to be returned signed by them in order for their child to partake in those classes.

3. Providing Advice:

The school's function is to provide a general education about sexual matters, not to offer any individual advice, information or guidance. However, sources of professional advice and information will be identified when appropriate.

4. Explicit Questions:

It may not be appropriate to deal with certain explicit questions in class. Teachers may say that it is not appropriate to deal with that question at this time. If a teacher becomes concerned about a matter that has been raised, he/she should seek advice from the SPHE Co-ordinator or the Principal. When deciding whether or not to answer questions, the teacher should consider the age and maturity of the students, the RSE programme content, the ethos of the school and the RSE policy.

5. Confidentiality

It is school policy that where a pupil is considered at risk of any type of abuse or in breach of the law, the teacher must refer this immediately to the Designated Liaison Person (the Principal). The Principal will decide whether or not to inform the parents and/or appropriate authorities according to the Child Protection Procedures for Primary and Post-Primary Schools (Dept of Education & Skills) 4.1.1. and 4.1.2.

7. Feidhm a Bhaint as Aoichtainteoírí agus Eile

Is é polasaí na scoile é gur fearr an chuid is mó den chlár OCG a phlé go hoscailte le múinteoirí a bhfuil aithne ar na daltaí orthu agus muinín acu as/aisti. Is féidir le cuairteoirí caighdeán an tsoláthair a fheabhsú, áfach, chomh fada agus a úsáidtear iad i dteannta chláir phleanáilte OCG, ní ina ionad.

Má shocraítéar ar aoichtainteoír seachtrach nó ceardlann seachtrach a chur ar bun ar ghné den chlár, caithfidh an múinteoir an treoir atá leagtha amach d'aoichtainteoírí a leanúint agus cead a fháil ón bPríomhoide roimh ré.

Cuirfear tuismitheoirí ar an eolas i scríbhinn maidir leis an aoichtainteoír / ceardlann seachtain roimh ré.

Cinnteoidh an múinteoir go bhfuil ábhar na cainte aois-oriúnach agus ag teacht leis an gclár don OCG.

8. Gnéaschlaonadh

Aithníonn na múinteoirí go bhfuil gnéaschlaontaí éagsúla ann atá inghlactha sa tsochaí agus dá bhrí sin tá sé dosheatanta agus tá sé nádúrtha go ndéanfar gnéaschlaontaí éagsúla a phlé i rith chláir oideachas gnéasachta. Ceann de na buntáistí a bhaineann le ceisteanna maidir leis an homaighnéasachas a chíoradh ná go dtugann sé deis tuairimí agus teoiricí bréagacha a cheartú agus tabhairt faoin réamhchlaonadh. Déanfar plé air seo ag státse atá aois-oriúnach do na daltaí.

The following is also school policy:

- Teachers cannot promise absolute confidentiality.
- Pupils are made aware that any incident may be conveyed to the Principal or possibly to parents, if the Principal decides that it is in the best interests of the pupil to notify a parent.
- Teachers must indicate clearly to pupils when the content of a conversation can no longer be kept confidential.

6. The Biological Aspects of the Programme:

It is school policy that the Science Department deals primarily with specialist information on the biological aspects of reproduction.

7. Visiting Speakers and Others

It is school policy that most of the RSE programme is best discussed openly with teachers who are known and trusted by the pupils. However, visitors can enhance the quality of the provision as long as they are used in addition to, not instead of, a planned programme of RSE.

If it is decided to bring in an external speaker / to run an external workshop for an aspect of the programme, the teacher must follow the guide set out for guest speakers and must get permission from the Principal beforehand.

Parents will be informed in writing regarding the guest speaker / workshop a week in advance.

The teacher will ensure that the subject of the talk is age-appropriate and conforms to the RSE programme. Visitors will be made aware of the RSE policy, the ethos of the school and the manner of delivery of the RSE programme. The teacher will be present for the talk, along with the guest speaker.

In order to inform the visitor of the precise requirements of a group and to make better use of the time of the visitor, it is advisable to draw up questions in advance and to forward them to the visitor. This will involve the pupils in the talk and also facilitates planning.

8. Sexual Orientation

The teachers recognise that different sexual orientations are acceptable in society and therefore, it is inevitable and natural that various sexual orientations will be discussed during a programme of sex education. One of the advantages of exploring issues concerning homosexuality is the opportunity given to correct false ideas and assumptions and to address prejudice. Discussion of this topic will be at a stage which is appropriate to the age of the pupils.

9. Riachtanais Speisialta

F. Tacaíocht, Forbairt agus Athbhreithniú Leanúnach

H. Monatóireacht, Measúnú agus Athbhreithniú an Chláir OCG / OSPS

9. Special Needs

It may happen that pupils with special needs may need more help in learning what sort of behaviour is suitable as they deal with the physical and emotional aspects of this programme. With parental permission, this support and help will be provided to prepare them for life and to make them vigilant of abuse by others.

10. Family Planning / Sexual Health

Family planning will be dealt with in an age-appropriate way and each aspect of the matter will be considered in an open manner.

Age-appropriate information will be provided in the senior cycle regarding safe sex practices and sexually transmitted infections.

F. Ongoing Support, Development and Review

Training

All teachers involved in this work do not necessarily have to be ‘experts’ on the issues concerned. However, they do require sensitivity to the needs of the group, an ability to deal with questions openly and honestly within the school ethos and in the context of God’s love, and that they would be willing to take advice and training.

The school will facilitate teachers to obtain expert training in this field by enabling them to attend in-service courses.

SPHE will not be put on a teacher’s timetable without consulting with the teacher first.

Teachers will be given the opportunity to hold meetings to plan the programme and to share expertise.

G. Resources

The school will use appropriate RSE teaching materials issued by The DES and the HSE which have been identified by staff as useful material and which have been approved by the Principal, within the normal budgetary framework and as general school resources allow.

H. Monitoring, Evaluating and Reviewing the RSE/ SPHE Programme

We are committed to monitoring and evaluating the effectiveness of this programme.

The monitoring and evaluation will be done by:

- Pupil feedback
- Staff review and feedback
- Parental feedback

I. Recording in RSE/SPHE Classes:

Every teacher has a class list in their journal. The teacher calls the roll at the beginning of every class to
